Dear Chairman Paul, Ranking Member Peters, Chairman Green, Ranking Member Thompson,  
Chairman Grassley, Ranking Member Durbin, Chairman Jordan, and Ranking Member Raskin:

We, the undersigned 85 local and national faith-based organizations, urge you to consider the constitutional rights and inherent dignity of all immigrants as you draft the budget reconciliation bill. Our faith traditions share a common call to seek the common good in public life, a commitment that extends to immigrants in our communities. Across our diverse faith traditions, we welcome people of all backgrounds, national origins, and incomes to partake in worship. If Congress were to approve the funding proposed under this bill to facilitate millions of deportations, it would shatter families and devastate worship communities.

Within the first three months, the administration has already massively stepped up immigration enforcement, detaining and deporting immigrants across immigration statuses. Increasing funding for Immigration and Customs Enforcement (ICE) and Customs and Border Protection (CBP) under the Department of Homeland Security (DHS) undermines the stability and well-being of immigrant families and the broader community. Increasing funding for immigration enforcement by the unprecedented margins proposed in the budget reconciliation bill would exacerbate the climate of fear permeating our communities and supercharge widespread deportations.

The current proposals to provide at least \$200 billion in immigration and border enforcement funding in the reconciliation bill demonstrate a concerning shift in federal government priorities

away from supporting the basic needs of Americans. In the two decades since the U.S. Department of Homeland Security was created in 2003, Congress has provided an estimated combined total of \$409 billion for ICE and CBP. Providing at least \$200 billion in immigration and border enforcement would amount to an increase of more than 43% in a single bill. To meet deficit targets, committees may propose tax-and-spending policy changes such as additional restrictions for safety net programs Americans rely on. Cutting human needs to fund a massive increase in immigration and border spending shifts federal government priorities away from providing for the basic needs of the American people.

ICE and CBP have a history of infringing on human and constitutionally protected rights. Conditions of negligence, abusive solitary confinement, harassment and discrimination, and substandard conditions are well documented throughout ICE's expansive network of detention facilities.<sup>1</sup> ICE contracts out the daily operations for its vast network of immigration detention facilities to numerous for-profit prison companies. GEO Group, one of these, has secured three new federal contracts, collectively representing around 5,000 new detention beds in the last three months.<sup>2</sup> Most concerningly, immigration enforcement has significantly expanded in scope in the past few months. Hundreds have been detained in foreign prison camps;<sup>3</sup> lawful permanent residents "green card holders" with non-violent records are being detained;<sup>4</sup> and ICE has detained and sought to deport valid visa holders who participated in public protests.<sup>5</sup> U.S. citizen children and individuals with tribal membership have also been swept up in deportation operations.<sup>6</sup> Internationally recognized human rights of concern include the right to worship, work, seek asylum, an adequate standard of living, a fair trial, freedom and expression and peaceful protest, and the right not to be arbitrarily arrested or detained.<sup>7</sup> Increasing funding for agencies that cause harm to immigrants and infringe on international norms contradicts our faith's moral call to love our neighbor as ourselves and welcome the immigrant.

Immigrants are active participants in many of our congregations and places of worship and are integral to religious communities. The current efforts of the government to carry out the removal of all immigrants who enter or remain in violation of immigration law have led many to abstain from attending worship and being involved in their faith community.<sup>8</sup> Our religious communities run a broad array of ministries that are often co-located at places of worship where they serve as community hubs. These ministries provide food for the hungry, shelter for the unhoused, ESL and citizenship classes to immigrants, and humanitarian and disaster response aid. In particular, the rescission of the protected areas guidance, which emboldens ICE to conduct enforcement actions at places of worship, schools, and hospitals without prior authorization, has significantly impacted these programs. It has reduced the number of participants who feel safe seeking assistance, thereby diminishing the effectiveness and reach of our ministries.

The aftermath of the 2019 worksite raids at Mississippi poultry plants illustrates how intensified immigration enforcement can have lasting effects on communities. These raids, among the largest in history, led to the separation of hundreds of families, overwhelmed the immigration court system, and exacerbated an injustice by prosecuting the immigrants affected by the raids, while no top executives faced indictment.<sup>9</sup> In light of today's shifting policies, one survey found that 58 percent of mixed-status families feared that they or someone they loved could be deported.<sup>10</sup> It's important to recognize that immigrants, like any group of people, are diverse and cannot be generalized as threats. Many people with no criminal background who have lived in this country for decades, those who have temporary lawful status, and in some cases individuals with permanent legal status have nevertheless expressed fear of deportation or worry they may lose their status or permission to remain in the U.S. Researchers point to the toxic stress and negative mental health impact on children of immigrants.<sup>11</sup> It is estimated that in the U.S., 5.5 million U.S. born children live in households with at least one undocumented resident, including 1.8 million living in households with two undocumented parents.<sup>12</sup> Congress could exercise restraint by focusing enforcement funding on apprehending and detaining those who genuinely pose a threat to society, rather than targeting individuals like a father leading his family to worship service.

We urge you to consider the impact of heightened enforcement on religious communities as you consider immigration and border enforcement funding in the reconciliation package. With larger funds, immigration and border enforcement will continue to infringe on the human and constitutional rights of immigrants at a much larger scale and with less accountability. With larger funds, ICE raids will be more frequent, leading to a chilling effect that may leave more congregants feeling unsafe participating in worship services or turning to our congregations and organizations in times of need, undermining our role as key pillars of support in our communities. Spanning broad traditions, our sacred texts and traditions offer a clear and consistent call to love immigrants as our neighbors. We urge you to reject dramatically increasing funding for immigration enforcement and instead turn toward policies that strengthen our communities so we all can thrive.
